Busking Updates

Busking has been an integral part of Sydney culture throughout the years. Property NSW and CBRE recognize the vibrancy and life that our buskers bring to the precinct.

We would like to welcome you back to showcase your talents from **2 June 2020**. To adhere with social distancing requirements the types of busking we welcome at this point are walk by acts, no amplification and indigenous busking.

All buskers need to adhere to all Department of Health (DoH) guidance, and social distancing requirements. Please be guided by the following restrictions from 2nd June 2020 until further notice

- All buskers must communicate and remind their audience about social distancing requirements of 1.5 meters from one person to another
- All buskers must maintain 1.5 meters distance from others and practice good hand hygiene
- **Circle Acts and Group Performances are restricted until further notice.**
- No Special Permit safety assessments will be conducted and thus no new permits will be issued
- Rangers may stop the acts that do not address the social distancing requirements within their audience as well as themselves
- If you had travelled overseas and recently returned, or if you have come into contact with a confirmed case of COVID-19, you must self-isolate for 14 days.

A range of additional pitch locations are now available for you to utilize. These new locations will be on a three-month trial basis and will be reviewed for the opportunity to make them permanent. Please find the updated busking map on the next page. There are three locations which will require booking to curate performances and ensure events are not occupying the space.

To book pitches 16 and 18 please provide the following information:

- Pitch location and time
- Valid busking permit
- Video or link to a recent performance (for pitches 16 & 18 only)

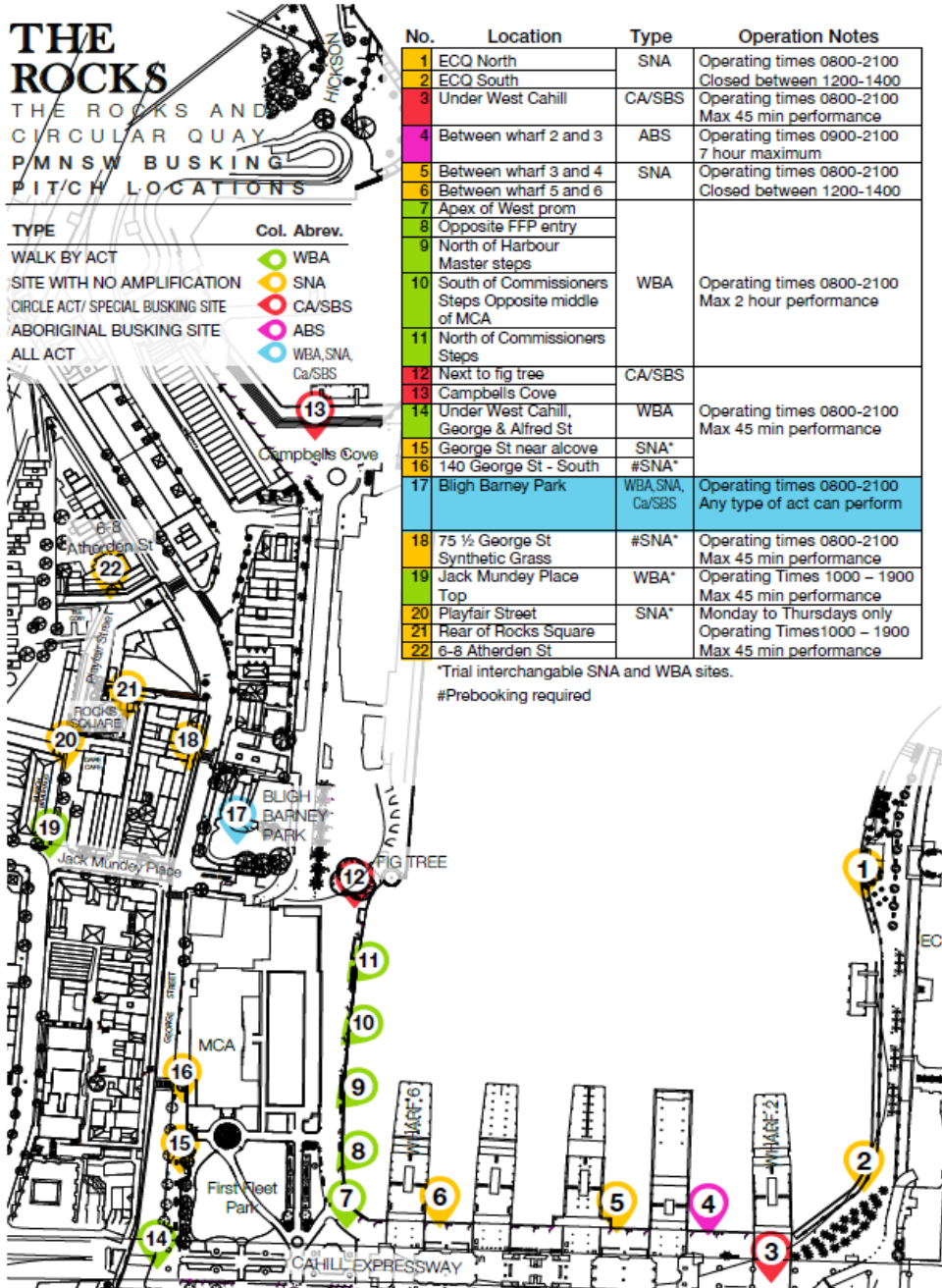
